FIELDS OF APPLICATION

PANTARHIT[®] CBS 820 (BV) is a special admixture solution designed for allowing the use of challenging aggregates e.g. clay containing sands in readymix and precast concrete applications.

The special product composition creates a blocking system which reduces clay's capacity to absorb concrete admixtures, making them ineffective. The blocking effect ensures enhancing the effectiveness and performance of superplasticizers or plasticizers and helps to control the concrete technological challenges when using clay containing aggregates.

Therefore, PANTARHIT[®] CBS 820 (BV) provides the following benefits to concrete:

- Controlled consistency retention
- Stable water demand
- Controlled workability
- Sufficient plasticizing effects
- Economical dosage level
- Allows formation of low-viscosity concrete
- Meeting the required w/c-values

PANTARHIT[®] CBS 820 (BV) gives concrete producers the opportunity to use difficult aggregates which were previously unsuitable for the concrete production.

This enables concrete manufacturers to realize considerable cost savings.

DOSAGE

Recommended dosage range 0.2 - 2.5 mass-% of the cement content; is equivalent to 2 - 24 ml per kg cement.

WORKING PRINCIPLE

PANTARHIT[®] CBS 820 (BV) neutralises the strong water absorbing attributes of clay containing aggregates by saturating their surface.

Combining the special admixture with a PCE-based PANTARHIT[®] high performance superplasticizer or plasticizer provides an ideal control over concrete's workability and its consistency retention.

It can be used in combination with a PCE-based PANTARHIT[®] high performance superplasticizer or plasticizer.

The mixing time must comply with the regulations defined in EN 206-1.
