Universally applicable form release agent for the concrete industry

FIELDS OF APPLICATION

VORMIOL Universal is a form release agent for a facilitated stripping of concrete from mould, boards, and formwork.

VORMIOL Universal is suitable for all wooden, metal and plastic formwork and can be applied to heated ones.

VORMIOL Universal allows an easy stripping of and enables the production of high-quality concrete surfaces with reduces blowholes, pores, and spots.

APPLICATION QUANTITY

Depending on the surface structure and its absorbing abilities the necessary amount might vary and has to be determined for each single application.

For metal and plastic formwork approx. 15 – 20 g/m² are recommended

For wooden formwork approx. 25 – 50 g/m² are recommended

WORKING PRINCIPLE

VORMIOL Universal works chemically/physically. The synergy between the contained additives and solvents generates an excellent separating effect. The reduced adhesion between concrete and formwork minimises both damages on the produced concrete products or elements and on the formworks.

VORMIOL Universal contains anti-corrosive additives which decrease the corrosion risk on steel moulds and allow an extended usage period of them.

PROCESSING INDICATIONS

Surfaces of formwork should be dry, clean and free of loose particles. Contaminations have to be completely removed.

VORMIOL Universal is a ready-to-use agent and should be applied thinly and evenly to the complete surface to form a homogenous coat on the formwork. A suitable spraying system should be used for the application.

The stripped concrete surfaces can be used for further coatings like plaster because concrete's adherence is only insignificantly influenced.
